## NOTICE OF INTENTION TO GRANT FRANCHISE: FOR THE JANUS SOLAR AND BATTERY STORAGE PROJECT

NOTICE IS HEREBY GIVEN that Janus Solar PV, LLC, a Delaware limited liability company, has requested that the Board of Supervisors of the County of Colusa grant it a franchise to construct, erect, renew, repair, maintain, operate, and remove or abandon in place (if acceptable to the County) a system of electric transmission lines, cables, conduit, connections, fittings and other related appurtenances and facilities necessary or convenient for the operation of said system of electric lines (hereinafter, the "Transmission Lines") within portions of the public right-of-way along Spring Valley Road and Walnut Drive, as more specifically shown on Exhibit A of the proposed ordinance, in the unincorporated territory in the County of Colusa, State of California.

If granted, the franchise shall be for a period of 35 years. During the term of the franchise, Janus Solar PV, LLC, its lawful successors in interest, in whole or in part (herein referred to as "Grantee"), shall annually pay to the County, in lawful money of the United States, a franchise payment (hereinafter the "Right-of-Way Occupancy Fee") consistent with the payment provisions amounting to two dollars and fifty cents (\$2.50) per linear foot of Transmission Lines installed within the public right-of-way, subject to a three percent (3%) annual increase.

Grantee will be responsible for payment of the Right-of-Way Occupancy Fee until such time as the Transmission Lines are removed or abandoned in place with the County's authorization. In the event the payments specified herein are not made in accordance with the terms of the franchise, the franchise shall be forfeited following the applicable cure period.

NOTICE IS HEREBY FURTHER GIVEN that any person objecting to the granting of the franchise may appear before the Board of Supervisors and be heard thereon at the hour of 9:00 a.m. on Tuesday, the 25th day of March, 2025, at the Board of Supervisors Chambers located at 546 Jay Street, Suite 108, Colusa, California.

NOTICE IS HEREBY FURTHER GIVEN that at any time not later than the hour set for the hearing of objections, any person interested may make written protest stating objections against the granting of the franchise, which protest must be signed by the protestant and be delivered to the Clerk of the Board of Supervisors. The Board of Supervisors may adjourn the hearing from time to time.
