WINNING, TIE, RUN-OFF AND TOP TWO CANDIDATES NONPARTISAN CANDIDATES

CANDIDATE RECEIVES MAJORITY VOTE

Any candidate for a nonpartisan office who at a primary election receives votes on a majority of all the ballots cast for candidates for that office shall be elected to that office. Where two or more candidates are to be elected to a given office and a greater number of candidates receive a majority than the number to be elected, those candidates shall be elected who secure the highest votes of those receiving a majority, and equal in number to the number to be elected.

Where a candidate has been elected to a nonpartisan office at the primary election that office shall not appear on the ballot at the ensuing general election, notwithstanding the death, resignation, or other disqualification of the candidate at a time subsequent to the primary election.

NO CANDIDATE RECEIVES MAJORITY VOTE

If no candidate received a majority of votes, the top two candidates will run off in the general election.

TIE VOTE

In the case of a tie vote, nonpartisan candidates receiving the same number of votes shall be candidates at the ensuing general election if they qualify pursuant to Section 8141 whether or not there are more candidates at the general election than prescribed by this article. In no case shall the tie be determined by lot.

VOTER NOMINATED CANDIDATES

TOP TWO CANDIDATES ON GENERAL BALLOT

Except as provided in subdivision (b) of Section 8142, only the candidates for a voter-nominated office who receive the highest or second highest number of votes cast at the primary election shall appear on the ballot as candidates for that office at the ensuing general election. More than one candidate with the same party preference designation may participate in the general election pursuant to this subdivision. Notwithstanding the designation made by the candidate pursuant to Section 8002.5, no candidate for a voter-nominated office shall be deemed to be the official nominee for that office of any political party, and no party is entitled to have a candidate with its party preference designation participate in the general election unless that candidate is one of the candidates receiving the highest or second highest number of votes cast at the primary election.

(b) In the case of a tie vote among candidates at a primary election for a voternominated office, the following applies:(1) All candidates receiving the highest
number of votes cast for any candidate shall be candidates at the ensuing general
election whether or not there are more candidates at the general election than
prescribed by this article. (2) Notwithstanding Section 8141.5, if a tie vote among
candidates results in more than one primary candidate qualifying for the general
election pursuant to subdivision (a), candidates receiving fewer votes shall not be
candidates at the general election, even if they receive the second highest number
of votes cast.(3) If only one candidate receives the highest number of votes cast but
there is a tie vote among two or more candidates receiving the second highest

at the ensuing general election along with the candidate receiving the highest
number of votes cast, regardless of whether there are more candidates at the
general election than prescribed by this article. (4) In no case shall the tie be
determined by lot.

The estimated cost paid for the June election does not cover publishing the statement for both a primary and general/run-off election.

Between these dates, candidates choosing to file a candidate's statement for publication in the November county voter information guide must submit their statement and pay the estimated cost of the publication for the run-off election. Candidates may choose to publish the same statement or submit a new statement during this period.

RUN-OFF ELECTION

No later than 07/28/2025

BALLOT DESIGNATION DEADLINE

By this date, candidates may request to change their ballot designation.

The designation shall remain the same for all purposes of both primary and general elections, unless the candidate, at least 98 days before the general election, requests in writing a different designation which the candidate is entitled to use at the time of the request.
