Minimum residential septic tank size based on Table H.2.1 of the plumbing code.	Minimum residential septic tank size has been set at 120 gallons/day for the first three bedrooms plus 60 gallons/day for each additional bedroom.	Residential septic tank size is approximately 30 percent less than required under the plumbing code.		
Minimum non-residential septic tank size based on Table H.2.1 of the plumbing code which contains a standard formula.	Provides for the use flow equalization for facilities that experience regular and predictable fluctuations in wastewater flows.	Provides for additional flexibility in the design to prevent over building a system.		
The State standards do not have design modifications for drainage or flooding issues.	The local regulations have guidelines and criteria provided for, curtain drains (sub-drains), soil fill, and flood area mitigations.	Local standards implement additional flexibility at the local level.		
State Tier 1 Standards do not contain a variance process for deviations from standards.	The County's LAMP does contain a variance process and where OWTS do not meet horizontal separation requirements, the County can allowed deviation based on the standard of "meeting to the greatest extent practicable".	Provides additional flexibility over the State's minimum standards.		
For home additions and remodeling projects, the State standards require these projects be treated the same as new construction.	The County's LAMP guidelines provide standardized methods and criteria for evaluating operating conditions of existing OWTS in connection with house additions, remodeling projects, etc.	The implementation of this local standard provides greater flexibility than the State standard.		
For system repairs, the State requires meeting the code to greatest extent practicable. However, only standard systems may be authorized by County and RWQCB approval is mandated for any non-standard repair option.	The County's LAMP also specifies that the repair must meet the standards to the greatest extent practicable. However, multiple design options which are suited to site constraints may be authorized by County.	The implementation of this local standard provides greater flexibility than the State standard.
