Mary Fahey, Colusa County Water Resources reported on the following:

#### **Prop 1 Counties with Stressed Basins Funding Application:**

Colusa County was awarded a grant from the Department of Water Resources, Proposition 1, Counties with Stressed Basins, Sustainable Groundwater Management Program. The grant award is for \$250,000. The project includes new Monitoring and Data Management programs that will be integrated into a future Groundwater Sustainability Plan (GSP). The project is in the early stages and will be completed by March, 2018.

#### **Subsidence**

In 2008, DWR completed a GPS land subsidence survey in the Sacramento Valley. A limited resurvey of the Arbuckle area was completed in June, 2016 and revealed up to 2 feet of subsidence. DWR will resurvey the entire Sacramento Valley in spring, 2017. DWR is providing training, equipment and technical expertise while local agencies will provide field staff.

#### Phase I and Phase II Bay-Delta Plan Updates

Proposed new in-stream and Delta flow requirement currently under consideration by the State Water Resources Control Board could have a significant impact on surface water supplies. This will ultimately affect groundwater supplies which will hinder our SGMA implementation efforts. Commissioner Rolen discussed the proposed updates and that everyone needs to be engaged in these issues and support the surface water districts' efforts to protect surface water supplies in the Sacramento Valley.

#### **Groundwater Levels**

Ms. Fahey also handed out information on current groundwater levels compared to this time last year. Things look positive over last year, but long term, groundwater levels are still down.

#### 3. **DISCUSSION/ACTION ITEMS** (\*action item)

- a. DWR Update and Discussion; Roy Hull, Department of Water Resources, Northern Region Office Mr. Hull presented draft groundwater level change maps. These maps reflect groundwater level changes over time in Colusa County in wells at the 100'-450' range. The following timeframes were discussed:
  - a) Fall of 2015 to 2016. During this period, groundwater levels have mostly stabilized and some have come up.
  - b) Fall of 2011 to 2016 (2011-2016 is a period of drought). During this time period the average change in groundwater levels across the County is negative 10 feet, with some areas down as much as 50 feet.
  - c) Fall of 2004 to 2016 (2004 is considered a normal year). During this time period the average change in groundwater levels across the County is negative 15 feet.

Mr. Hull mentioned that the timing of the measurements has an impact on the measurements. Spring measurements may be more reflective of conditions. Fall measurements show levels just after the aquifers have been worked pretty hard.

**Question:** Can we say that we are on a recovery basis? **Answer:** Mr. Hull said that we are stabilizing but it will depend on precipitation. The demand for water hasn't changed. The wildcard is surface water supplies. The

take-away is that we have not recovered from the drought. We have stabilized but we are still at the bottom of the curve. Colusa County's Prop 1 funding to develop the monitoring network will be really helpful.

Mr. Hull reported that he has been spending a lot of time working on land use data. He is focusing statewide, not just Colusa County. In the past, DWR has been completing county land use updates just two or three counties at a time, so there are big gaps. Now they are working with Land IQ to complete remote sensing on a yearly basis. It's a 60 meter grid. They are looking at 2014, 2015, 2016. The data will be available as shapefiles. Locals will have to help vet some of the data. It is 95-98% accurate. We will have better information going forward. The Basin Prioritization team is gathering a lot of valuable data that will be available to the GSAs.

Mr. Hull discussed the Best Management Practices being developed by DWR for SGMA. They have posted several of them. They will be adding to them and updating them as living documents. They have completed a Monitoring Protocols BMP that will be helpful for Colusa County.

#### b. SGMA Update

i. GSA Workgroup

Ms. Fahey provided a quick SGMA update. The group's first order of business is to develop governance. The basins must be covered by GSAs with no overlaps by June 30, 2017. The group is considering a single GSA that will cover the entire county portions of the basins. We are working on an MOU that will eventually lead to a JPA. Private individuals are not allowed to be a GSA per SGMA, only public agencies are eligible. Colusa County supervisors recognized the important role that private pumpers play in SGMA and formed the Private Pumper Advisory Committee (PPAC). The original purpose was advisory only, but PPAC members advocated for role in governance. The supervisors and work group have agreed to this. Ms. Fahey mentioned that Colusa County has to coordinate with both Glenn and Butte Counties, and meetings are being set for staff and facilitators from each county. Conversations between supervisors in the three counties will also take place.

Mr. Williams mentioned that the language in the MOU has softened after several edits, which is good, however private pumpers are not signatories to the MOU. Mr. Williams has asked Ms. Fahey to agendize the MOU at a future PPAC meeting for review and discussion. PPAC members should be signatory to the MOU. Ms. Fahey mentioned that there is still time for the PPAC to develop Principles. Mr. Williams said that is not necessary. They are happy with the direction the MOU is heading, and the private pumpers have given input during the discussions.

#### **STAFF REPORT**

#### Water Resources Move as of February 1

As of February 1, 2017, the Colusa County Water Resources Division has moved from the Department of Agriculture, to the Department of Development Services (previously Planning and Building). Colusa County's Development Services Department consists of the Planning, Building, Environmental Health, and Water Resources divisions. The Board of Supervisors have combined these functions into a single agency in order to help facilitate the delivery of the highest level of customer service to the County's residents and businesses in support of agricultural activities and economic development.

#### **Prop 1 Counties with Stressed Basins Funding Application:**

Colusa County Water Resources Staff recently coordinated a meeting with Glenn County Water Resources Staff and the Consultant team that is working in both Colusa and Glenn Counties on their Proposition 1 grant funded projects. The purpose of the meeting was to determine which, if any, Work Plan items in the two grants could be integrated, without adding any costs. There are some overlapping tasks in the Work Plans. The Consultant team is working up a proposal. Any changes in scope of work would have to be approved by DWR.

#### Subsidence - Discussion on Agenda

DWR is providing training, equipment and technical expertise for a Sacramento Valley-wide subsidence resurvey in spring. The original timeline was March – June, 2017. This has been pushed back a month due to the situation at Oroville Dam which redirected many of DWR's resources. Local agencies throughout the region will provide field staff for the survey. Colusa County Water Resources staff is currently looking for two volunteers to participate in the survey.

#### **SGMA - Discussion on Agenda**

The Colusa County GSA Workgroup has been meeting regularly over the past year. The participating agencies agreed that a multi-party GSA covering the County portions of the basins is the best approach. The following agencies have been identified as participants on a multi-party GSA/JPA Board:

- 1. County of Colusa
- 2. City of Colusa
- 3. City of Williams
- 4. Glenn Colusa Irrigation District
- 5. Colusa County Water District
- 6. Princeton, Glenn Codora Irrigation District & Provident Water District
- 7. Reclamation District 108
- 8. Reclamation District 479
- 9. Maxwell Irrigation District & Westside Water District

- 10. Colusa Drain Mutual Water Company
- 11. 2 Private Pumpers
- 12. Reclamation District 1004 (potentially)

A draft Memorandum of Agreement (MOA) has been developed that integrates Guiding Principles from the various agencies. The group is working on a Joint Powers Agreement (JPA) to be the Agreement GSA Agreement that the parties will sign to meet the June 30, 2017 deadline. If the JPA cannot be completed by June 30, the MOA will be used as the Agreement until the JPA is completed.

#### **Pending GSA Issues for 2017:**

- Coordination with Glenn and Butte Counties to ensure SGMA compliance in the Colusa and West Butte Subbasins
- Determine JPA membership structure and voting structure
- Determine Private Pumper membership structure
- Determine budget and funding structure
- Determine whether the JPA covers just the Colusa Subbasin, or the Colusa and West Butte Subbasins
